**BACKGROUND:**

This report provides a tabulation of voluntary annexations received for the month of November.

The Planning Council received a total of two voluntary annexation petitions in November from the City of Clearwater. Both proposed annexation properties contain single-family homes. The proposed annexations totaled about 0.5 acres and \$236,310 in taxable value. Total MSTU tax revenues from the \$236,310 of taxable value are \$493 using the 2008/09 fiscal year tax rate.

Table 1 describes each of the voluntary annexation petitions received in the month of November, including when the Planning Council staff received the petition, the annexing municipality, acreage, taxable value, estimated population affected, and property use.

Table 2 provides a cumulative log for all voluntary annexations received subsequent to the invalidation of Ordinance No. 00-63 on October 17, 2007, by municipality.
