***BACKGROUND***

This information is presented in order to better and more systematically apprise the Council of final action by the Board of County Commissioners/Countywide Planning Authority on matters that have been considered by the Council.

**At their January 5, 2010 meeting, the CPA took the following actions:**

**Public Hearings**

**Regular Amendments:**

- Case CW 97-62 (SAP Change No. 1-2009), City of Largo West Bay Drive Redevelopment Plan. The Board **approved** the amendment of the Special Area Plan for the Community Redevelopment District (vote 7-0).
- Case CW 09-28, a Pinellas County case generally located east of the St. Petersburg-Clearwater International Airport, north of Old Roosevelt Boulevard and west of Evergreen Avenue (34<sup>th</sup> Street North) involving a portion of the Airco Golf Course site. The Board **approved** the amendment from Recreation/Open Space to Commercial General (vote 6-1).
- Case CW 09-29, a Pinellas County case generally located east of the St. Petersburg-Clearwater International Airport, north of Old Roosevelt Boulevard and west of Evergreen Avenue (34<sup>th</sup> Street North) ) involving a portion of the Airco Golf Course site. The Board **approved** the amendment from Recreation/Open Space to Industrial Limited (vote 6-1).
