D. Annexation Report – December, 2009

BACKGROUND:

This report provides a tabulation of voluntary annexations received for the month of December, 2009.

The Planning Council received a total of seven voluntary annexation petitions in December from the cities of Clearwater, Largo, Pinellas Park, Safety Harbor, and Tarpon Springs. The proposed annexations contain one office use, twelve residential uses, and 2 vacant parcels. The proposed annexations totaled 2.7 acres and approximately \$1.1 million in taxable value. Total MSTU tax revenues from the \$1.1 million of taxable value are approximately \$2,285 using the 2009/10 fiscal year tax rate. It is estimated that 22 residents will be affected by a change in jurisdiction. Five enclaves will be reduced by 1.13 acres and three enclaves totaling 0.54 acres will be eliminated.

Table 1 describes each of the voluntary annexation petition received in the month of December, including when the Planning Council staff received the petition, the annexing municipality, acreage, taxable value, estimated population affected, and property use.

Table 2 provides a cumulative log for all voluntary annexations reviewed during Fiscal Year 2009/10, by municipality.
