**BACKGROUND:**

This report provides a tabulation of voluntary annexations received for the month of March, 2010.

The Planning Council received a total of five voluntary annexation petitions in March from the cities of Clearwater, Oldsmar and Pinellas Park. The proposed annexations contain one commercial use and four residential uses. The proposed annexations totaled 1.75 acres and approximately \$883,000 in taxable value. Total MSTU tax revenues from the \$883,000 of taxable value are approximately \$1,843 using the 2009/10 fiscal year tax rate. It is estimated that 21 residents will be affected by a change in jurisdiction. One of the five annexations will reduce an enclave in the county by 0.29 acres.

Table 1 describes each of the voluntary annexation petition received in the month of March, including when the Planning Council staff received the petition, the annexing municipality, acreage, taxable value, estimated population affected, and property use.

Table 2 provides a cumulative log for all voluntary annexations reviewed during Fiscal Year 2009/10, by municipality.
